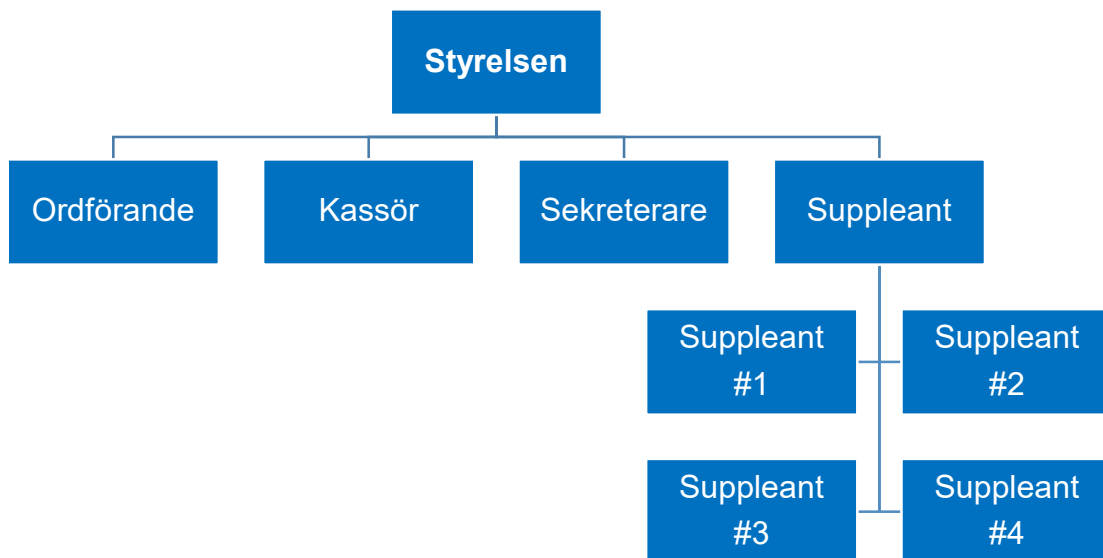
#### Trainings and activities carried out during the year (Utbildningar och aktiviteter som genomförs under året)
